

**ENTO SID RWY 18 (RNAV) - ROUTES**

<b>GENERAL:</b>	Surveillance service shall be available
<b>RADIO COMMUNICATION FAILURE:</b>	Squawk A7600. Maintain last assigned LVL for 2 minutes, then climb to CPL cruising LVL. Aircraft under vectoring shall, after set transponder to A7600, continue on the last cleared and acknowledged heading and level for 2 minutes, then proceed via the most direct route to join the cleared SID or route and climb to the cruising level stated in the CPL.
<b>CLOSE-IN OBSTACLES:</b>	Close-in OBST (trees) in DER area (end of CWY) E and W of extended RWY CL
<b>VECTORING/ DIRECT ROUTING:</b>	When being vectored or cleared for DCT routing, the climb gradient(s) stated in SID "RESTRICTIONS"-table apply.
<b>NON RNAV 1 ACFT:</b>	At first contact with (TORP TWR) state "UNABLE RNAV 1 DUE (reason)". OMNI-DIRECTIONAL DEPARTURE available (see ENTO AD 2.24)

<b>VATEX 2G</b> (VATEX TWO GOLF DEPARTURE)	Climb on course 175° to TO909, turn left to TO419, to TO421, to VATEX.	MNM climb gradient 6.6% (401 FT/NM) to 4000 FT. If unable to comply, inform ATC. MAX 220 KT IAS at TO909.	4000 FT. Expect further climb from Farris APCH.	When instructed by TORP TWR, contact FARRIS APP 134.055 MHZ.
